Date: January 11, 2017

Objectives:

To provide the Board with the 10-Year Capital - School Renewal Project Plan for the period 2016-2017 to 2025-2026 and to make a recommendation for approval.

History/Background:

Starting in 2011-2012 the Board has prepared a 10-Year Capital - School Renewal Project Plan (the plan) that is updated each year. The purpose of the plan is to highlight proposed school renewal project activities under the following project types:

Building Envelope Heating/Mechanical Systems

Electrical/Lighting Energy/Controls
Site Improvements Accessibility
Code/Regulatory Small Capital

School Renewal

At the August 30, 2016 Education, Policy & Operations meeting, staff provided a report highlighting the Ministry of Education's June 2016 announcement of \$1.1 billion to repair and renew schools across the province.

The total 2016-2017 funding for School Renewal and School Condition Improvement (SCI) for LDSB resulting from the \$1.1 billion announcement combined with the earlier release of the 2016-2017 Grants for Student Needs funding are as follows:

Community Hubs Capital

In October 2016, the Ministry of Education released details of a \$50 million community hubs capital funding program to support minor retrofits and accessibility projects in schools. Examples of how this funding could be used, include renovating available classroom space for use by a community partner; adding security doors; addressing accessibility barriers through the installation of ramps.



The Ministry of Education clarified that the community hubs capital funding is not to be used to expand the footprint of the building, to be used in schools scheduled to be closed in the next five years and for child care retrofits. Also, the funding is not to be used in new school construction projects or to make space available for community use of school groups after the regular school day. The Community Hubs Capital Funding -Minor Retrofits and Accessibility funding allocation for LDSB is as follows:

Analysis/Observations:

School Renewal

The Facility Services Department has developed the 10-year school renewal plan based upon the VFA Building Condition reports for all schools; analysis from maintenance work orders; knowledge from facilities trades and maintenance staff, and expertise from engineering and other consultants.

The 10-year plan includes a current year, 2016-2017 listing of projects by school or various schools where project work will be grouped together. Project work estimates are based upon best available information at the time.

As funding has yet to be announced for the 2017-2018 to 2025-2026 school years, the 10-year plan includes \$3,900,000 of projects identified by project types, to be supported by an estimate of School Renewal Funding during this timeline, which is based upon prior year funding levels.

Community Hubs Capital

The 10-year plan includes a current year, 2016-2017 listing of projects by school that is supported by the new Community Hubs capital funding of \$742,431 for minor retrofits and accessibility projects in schools.

The listing of projects developed by the Facility Services Department focused on accessibility projects at schools to support potential new partnerships and to support existing community partnerships. As such the following school facilities were selected:

- Clarendon Central P.S., Joyceville P.S. and North Addington Education Centre as these are the three schools in the Board identified with underutilized space available for potential partnerships per Policy #20;
- All secondary schools in the Board, except schools opened in the last five years and schools expected to be closed in the next five years per LTAP.
- The Limestone Education Centre, the former Calvin Park P.S. facility.

Recommendations:

That the Board:

- Approve the 10-Year Capital School Renewal Project Plan for 2016-2017 to 2025-2026.
- That a copy of the 10-Year Capital School Renewal Project Plan be posted on the Board's website.
