#### Chair's Update

Chair Murray stated:

"Tonight's Board meeting marks the close of the fourth and final year of this Board's term in office. I would like to take this opportunity to thank my fellow Trustees for the work we have done this year representing our constituents, and ensuring students of the Limestone District School Board receive quality public education.

This year has not been without its challenges, and although that can be hard at times, Trustees remain focused on student achievement and well-being.

As this year ends, may we take a moment to be thoughtful and acknowledge some of the achievements attained over the term, including:

- Completion and roll-out of the Board's new Strategic Plan the development of a comprehensive vision to sustain us over the next several years.
- More students are graduating than ever before as a result of focused efforts by school teams as well as integrating specialty programs.
- The opening of Molly Brant Elementary School, and the construction of Kingston Secondary School.
- A 10-year Capital School Renewal plan.
- The introduction of the Kingston Transit Field Trip Pass for teachers and staff. This unique partnership between the Limestone Board and the City of Kingston is an innovative solution to reducing our collective carbon footprint, and is garnering much attention in municipalities across Canada, and internationally.
- The completion of the Rideau Heights Community Centre.
- We started our term with an updated Health and Physical Education curriculum & we conclude our term with a rollback. Serving in the education sector is not without its challenges, and of course, change. That is a constant.
- We also had to endure the loss of a colleague, and I know we are all deeply saddened by the sudden passing of Trustee David Jackson. That was a most difficult time, and for me is still very fresh.

Through all of this, Trustees remained focused on making decisions that effectively served all students.

On behalf of this Board of Trustees, I wish to acknowledge the leadership of Director Rantz and Limestone's Senior Staff for the development and delivery of initiatives that support student transitions, career paths, character development, and interventions that ensure success for all students.

Please accept our heartfelt thanks for always being student-focused, and for supporting all of us through this term.

And that concludes my comments."

#### **Director's Update**

Director Rantz stated:

"As the Chair mentioned, this meeting marks the completion of the fourth and final year of this Board's term. As we close out this term I would like to express, on behalf of the Senior Team, our appreciation for the work that you do to support the students and staff of the Limestone District School Board. Trustees, you should be proud of your contributions. You remained focused on advancing our vision to embrace and foster engaging and innovative learning where everyone achieves success and well-being.

I would also like to express my appreciation to Chair Paula Murray and Vice Chair Suzanne Ruttan for their service to the Limestone District School Board over the last year. Although Board business has, regrettably, been fractious at times, you have both conducted yourselves with decorum and mutual respect, and in a manner that is fitting to the executive positions you both hold on this Board. Thank you.

November is Indigenous Education Month and our schools are focused on honouring and learning about Indigenous perspectives, cultures, and the entwined histories of Indigenous and non-Indigenous peoples in Canada. The area covered by the Limestone District School Board is home to over 7000 First Nations, Métis and Inuit people. It is the traditional homeland of the Anishinaabe and the Haudenosaunee and is also home to Métis, Inuit and First Nations peoples from across Canada. We believe that all students need to know about the distinct cultures, traditions, and histories of First Nations, Métis and Inuit. I am pleased to say our staff have introduced innovative and engaging learning opportunities to help us move forward on the path to Reconciliation. This work is ongoing.

In addition to our work with Indigenous education, I would like to share some recent district and school initiatives that celebrate our innovative approach to learning and leading, and the positive impact we can have on our communities through a focus on wellness, innovation and collaboration – the pillars of this Board's strategic plan.

First, I would like to congratulate Creative Arts Focus Program coordinator and teacher Karen Peperkorn as recipient of the City of Kingston's Arts Champion Award. This award recognizes a living individual, organization or corporation who makes an extraordinary, leading contribution to the arts in Kingston as a volunteer, advocate, supporter, sponsor and/or philanthropist. Here is a short video recognizing Ms. Peperkorn's lifework as an arts educator."

A video of Karen Peperkorn was shared.

"Limestone schools played a leading role in the recent 'Socktober' campaign to collect socks for Kingston's area homeless. For the second year in a row, Mme. Adamson's class at Amherstview Public School led the charge with a goal of collecting 2,500 socks. The class went even further this year by challenging other schools. When the campaign wrapped up a few weeks ago, more than 10,000 pairs of socks had been collected and more than 7,000 of those were donated by Limestone schools and families. What a wonderful example of empathy and kindness, and how one small gesture can ignite a community to action.

On October 24, the Board hosted more than 400 female students in Grades 7 and 8 and 11 and 12, at a Women In Trades Day at St. Lawrence College. The day was made possible through funding from the Ontario Youth Apprenticeship Program and provided student participants with the opportunity to interact with and ask questions of women working in the skilled trades, and attend a trade show featuring different occupations involving the skilled trades. Our expanded opportunities team, led by Experiential Learning Consultant Geoff Petznick, interviewed some of the women in trades – including several Limestone graduates – who shared why they chose a career in the skilled trades and how their decision to explore an expanded opportunity program helped solidify their chosen pathway. Let's hear now from Logan Williams, an apprentice in auto body."

A video of Logan Williams was shared.

"In other news, you may have noticed that the Ontario Public School Boards' Association's online magazine 'Education Today' has highlighted some Limestone projects in its recent edition on unique and innovative projects to help students succeed. The fall edition highlights Ernestown Secondary School's Techno Math Project, as well as the Limestone/Queen's University's Tinker & Tech Trailer partnership – a mobile makerspace delivering workshops to students from Kindergarten to Grade 12.

As you can see, our strategic pillars of wellness, innovation and collaboration can be seen in action every day throughout the Limestone District School Board, and that will be part of this Board's legacy.

#### **Presentation: Student Voice Project**

Superintendent Babcock introduced Suche James, Equity and Inclusion Consultant, and Frontenac S.S. students Ryan Butterill, Sara Al Harthi, and Abigail Lesage-Cooper.

The Student Voice Project session occurred last spring, through a grant from the Ministry of Education. The engagement resulted in the following recommendations:

- Limestone District School Board will provide more and regular mandatory professional development training for all staff and K-12 teachers in social equity, anti-racism, and cultural competency
- 2. Limestone District School Board will adopt a K-12 gender neutral policy that includes the creation of gender neutral bathrooms in all schools, the adoption of non-gendered language by staff and teachers in all curricular documents, for discussions in class, and for non-gendered sports and sporting activities.
- 3. Limestone District School Board will provide for every K-12 school, a range of student approved posters, literature and videos, library resources and more guest speakers that

- support learning and growth in a safe and welcoming space that recognizes and respects LGBTQ2S+, Indigenous, and Racialized youth.
- 4. Limestone District School Board will increase mental health and wellbeing support training and qualifications for K-12 educational support workers, Counselors, and Administrators with a focus on LGBTQ2S+, Indigenous, and Racialized content.
- 5. LDSB will organize regular Student Voice day events in elementary, middle, and secondary schools where students who identify as LGBTQ2S+, Indigenous, and Racialized have an opportunity to share their personal stories and experiences in a safe, welcoming, and supportive space.

The students shared their personal stories related to their experiences in school as racialized, Indigenous or LGBTQ students.

Trustee Murray thanked the students for their honest and moving presentation.

Trustee Ross reported that OPSBA has released its Priority Development & Action document, which will cover five key areas:

- 1. The Whole Child and Student Well-Being for Today and Tomorrow
- 2. Advancing Reconciliation: First Nations, Métis and Inuit Education
- 3. Trustees as Leaders in Public Education
- 4. Education Funding
- 5. Labour Relations

OPSBA has created a resource for members on the Provincial Education Reform Consultation.

The Education Program Work Team meeting is on Friday.

#### (b) Report from Student Trustee(s)

Student Trustee Hart:

"Thank you, Madame Chair.

On Wednesday October 24th till Sunday October 28th, Sean and I attended the OSTA-AECO Fall General Meeting, and it went very well. At this conference we had many keynote speakers such as Norah Marsh from EQAO, who gave many key points about the changes and the future of provincial standardized testing, as well as a presentation from OPHEA Canada, a non-profit organisation whose goal is to improve the health and physical education of all students by developing new ground-breaking programs and services within schools across Ontario. It was also learned that two schools in our board are active participants of this program.

Throughout this conference some other key points that were learned was to not be afraid to get involved and share your ideas with others, over all else school comes first, and lastly that being a Student Trustee is an exceptional position that provides the Student Trustees with professional development as well as lots of opportunities for the future. There was also a presentation from a fellow Student Trustee Sarah Chun, one of three Student Trustees from the Thames Valley District School Board, who discussed an initiative that she developed to provide all high school girls with immediate access to tampons within their schools, which she called Free The Flow.

There were also several leadership opportunities, including several breakout sessions in order to create creative and/or new ideas for students regarding several different topics, several debates regarding new resolutions of OSTA-AECO, which include decreasing the number of students allotted to a Guidance Counselor/Adolescent Care Worker and improving course selection or improving access to schools for the rural students of Ontario.

Unfortunately, the scheduled Inter-School Council Meeting for this month had to be rescheduled due to scheduling issues. The new date for the meeting is currently being discussed, however, we do have a few updates. The date for this year's Inter-School Coffee House has been set for Tuesday, December the 11th at LCVI from 6 p.m. to 9 p.m. The council has decided that we are also going to make it a fundraising event, to which we are donating the funds we gather to the United Way. The beginning processes of the Inter-School Lip-Sync Battle Royale have also begun as well.

Those are all of the updates from the Student Trustees.

#### 2. Reports for Information

a) Strategic Action Plan 2017-2018

Director Rantz stated that the she and Senior Staff would be providing Trustees with an end-of-year status report on the 2017-2018 Strategic Plan.

Under the Education Act, the director must review the Multi-Year Strategic Plan (MYSP) annually with the Board of Trustees, normally timed to align with the Director's Annual Report at the end of the calendar year. To assist Trustees with their ongoing monitoring, a spring update was provided on May 29, 2018 using a 'traffic light' system to evaluate the progress of specific actions, which were designed to operationalize the achievement of the Board's strategic goals. A semi-annual assessment allows staff to make adjustments to ensure that the MYSP goals remain on track.

Staff's commitment to Trustees is that the areas of focus will also populate Board and EPOC agendas throughout the five-year Strategic Plan, thereby providing ongoing monitoring opportunities.

Senior Staff provided information on several areas that had received a yellow or red traffic light:

Associate Superintendent McDonnell spoke to providing professional learning opportunities to administrators to build capacity in creating and leading mentally healthy schools. Leading Mentally Healthy Schools-A Resource for School Administrators; School Planning for Sustainable Practices in Mental Health and Well-Being and School Mental Health Decision Support Tool have been developed, with professional learning beginning in September.

Associate Superintendent Sartor spoke to creating a K-12 ESL continuum of support for educators. The team wanted to begin with a K to 12 tool, but currently it is 1 to 12. The kindergarten piece is under development.

Associate Superintendent Gillam spoke to the work with LDSB's Police Board Protocol Partners to ensure that our policies and procedures are continually adapting to new laws and legislation. The last protocol was signed in 2016, and is due to be resigned this year. It has been challenging getting all parties together to update the document. The new protocol should be ready in January 2019.

Superintendent Babcock spoke to increasing the number of schools registering as ECO Schools. At present only 4 LDSB schools have certified. First time schools include Granite Ridge and Sinclair P.S. Staff have experienced issues in scheduling the training sessions, including inclement weather. Staff will continue the work, and new workshop times are being planned.

Superintendent Silver spoke to two Elementary Administrator groups being supported to focus on building their instructional leadership capacity in mathematics. One group experienced issues because the resource they planned to be used was not ready in time for the project start. When it was ready it was cost prohibitive. This team continued as a learning team only. New groups have been formed to continue the work.

Superintendent Burra spoke to improving end-user effectiveness with the Minds Online Virtual Learning Environment. The Bright Space contract has finally been signed with the province for a 10-year term. Now there is direct access from the platform to a whole range of tools and products. A parent portal is now also available, which staff will be piloting in the near future.

Superintendent Babin spoke to the Pupil Accommodation Review process. Boards are still awaiting direction from the province.

#### Regular Board Meeting Minutes Limestone District School Board

Superintendent Babin spoke to the Cashless Schools system. The pilot will be beginning soon and staff from the pilot schools are to be trained on the PA day in November.

Superintendent Labrie spoke to finalizing and publishing all collective agreements. He reminded the Board that the last round of arbitration created all new agreements. The current issue is how to manage the historical aspects without making the document too large. The work will move forward very soon.

Superintendent Labrie spoke to acquiring Thrive software and a hiring project coordinator to integrate the program with SmartFind to manage professional development costs and replacement processes. Mid-project the company changed ownership and the new owner is not going to support that version of the product. A new product will be selected.

Trustee Chadwick inquired if ECO schools is still a valuable program, as most sites would have lots of environmental wok going on that is maybe not being recognized. Superintendent Babcock replied that staff revisited the program. Staff have changed how it is being marketed and there are new ways to gain points, including using outdoor spaces in learning. The Board also now offers a workshop where participants do the registration together and evaluate how many points they already have.

Trustee Chadwick asked if the Accommodation Review process has received any insight or direction from the Ministry. Superintendent Babin replied that it has not. The previous government had a process in place, then placed a moratorium on school closures. There have been no updates from the new government.

Trustee Ross asked if Limestone was the only Board looking to use Thrive software. Superintendent Labrie replied that there were other boards looking into its use. LDSB chose this software as it aligned with the board's current systems. The new company that took over is American and did not want to support this market. The Board is now looking at other solutions.

Trustee Ruttan asked if there is a way to align the mental health leads with the student voice project. She stated that the student voice should inform mental health supports in schools. Superintendent Babcock answered that staff are having ongoing conversations about student wellness, which is directly related to student voice. Senior staff have also incorporated student focus groups into elementary school visits. Staff are trying to incorporate student voice in as many ways as possible to assist and support all students.

Associate Superintendent McDonnell noted that there had been a gap around the equity piece on the mental health committee. The committee now has Suche James and two students to help rectify the issue.

Trustee French asked what the area of math will see in year 2 of the plan. Superintendent Silver answered that the team has shifted work to have more focus on the junior grades, as provincially these grades are the biggest challenge. There is also a focus on assistive technology.

Trustee Garrod stated that the format is very unique in terms of a strategic plan. It is a very comprehensive and useful document, that is easy to access. He complimented the Director and Senior Staff on how well the strategic plan is being applied to the work of staff.

Student Trustee Hart asked if a student voice event will happen in elementary schools. Superintendent Babcock replied that staff intend to implement this during school effectiveness visits, and have added focus groups of students in grades 4-8.

Director Rantz stated that a data column had been added to show the data sets used to evaluate the progress.

Superintendent Babcock spoke to students reporting feeling safe and accepted in schools. Senior staff were concerned about some of the data collected in the last school climate survey. They have done a deep dive into the survey to understand the answers and to make adjustments to how data is collected as needed.

Associate Superintendent McDonnell spoke to educators demonstrating principles from Universal Design for Learning during instruction and assessment. This concept has been embedded in the *Learning for All* document for many years. Staff are beginning their journey in this area, and Senior Staff has recognized need to focus on the program team as this unfolds.

Associate Superintendent Gillam spoke to the Parent Engagement Strategy that reflects multi-faceted and diverse approaches to communicate and engage with parents. Senior Staff is always working to increase parent engagement, by using resources like google docs to allow more people to provide input. PIC meetings rotate between sites to allow more parents to attend. Senior Staff are working to engage with new community partners that have not been brought to the table.

Director Rantz clarified that a yellow dot means there is progress happening, not that work in a particular area has halted. In these areas Senior Staff are working to solve the unknowns.

EPOC meetings have been a place for Senior Staff to share strategy and an explanation of work with Trustees, while Board meetings include a presentation to bring the work alive.

A new video, One Year In, is being created to show the work involved in the roll out of the new strategic plan.

Trustee Ross stated that the Areas of Focus Progress Update was a very useful document. He suggested it should be included in every strategic plan update.

Trustee French stated that at first she had been resistant to the new plan format, but that now she really appreciates the format and how the evaluation comes back to the Board. She agreed that the Areas of Focus Progress Update document shows how the work is being accomplished.

The Board values the role and contribution of our families and their commitment to parent involvement, communication and consultation.

During the new term, we will open Kingston Secondary School. Constructions is well under way and the shell of the 171,000-square-foot facility is taking shape. Work continues on the site, however, unforeseen delays and disruptions have, unfortunately, put the project behind schedule. Given the size and scope of this large and complex project, setbacks such

as this sometimes occur. While this is disappointing news, the contractor remains focused on completing construction as soon as possible, but these recent delays will prevent us from opening the new school in September 2019 as planned.

A revised construction schedule is being developed and will be shared soon. We do expect to move students and staff into the new completed building within the 2019-2020 school year.

Next year, the Limestone Learning Foundation will celebrate its 20th year of supporting excellence in education. Our thanks to the Foundation's Board of Directors and volunteers for investing in our students' future.

This Saturday, December 15, 60-plus students, LDSB alumni and special guests will perform in the Crystal Concert Series at the Grand Theatre. A musical celebration for the holidays, and recognition for two-decades of funding innovative learning opportunities across this school district.

Limestone students are supported in so many ways by not-for-profit organizations, like the LLF, that truly make a difference in our students' well-being and success. Community organizations like the Greater Napanee Community Foundation, Loving Spoonful, The Food Sharing Project, Boys & Girls Club, Youth Diversion, KASSA and LESSA KFL & A Public Health, Kingston and Area Community Foundation, and the United Way, are just a few, of the many dedicated groups that provide bursaries, as well as programming and funding, for schools and students. Thank you.

Director Rantz and Senior Staff, on behalf of all Trustees, thank you all for your dedication to our students, staff and to this Board. Your expertise and leadership ensures our schools provide an environment where everyone achieves success and well-being.

As we begin a new term, and celebrate Limestone's 20th anniversary, Trustees will remain focused on furthering our Strategic Plan: to improve student achievement, ensure equity, inclusion and well-being, and enhance engagement, accountability and sustainability.

In closing, I would like to extend my appreciation again to staff, parents, families, and Limestone communities, for your outstanding work on behalf of students this past year. Best wishes for a wonderful holiday season!"

## 5. <u>Community Partner Presentation: Family and Children's Services of Frontenac Lennox and Addington – Charlene Whalen</u>

C. Whalen stated that the mandate of the Family and Children's Services of Frontenac Lennox and Addington is:

- To provide case management, supportive counselling, individual program plan development and monitoring, referrals, advocacy, assessment services to resident families of Lennox & Addington County with children from birth to 18 years who have a developmental disability
- To support the development of quality services for children with developmental disabilities
- To educate the public and professionals as to the issues, rights and needs of children with developmental disabilities

Lennox & Addington Family and Children's Services began by submitting a proposal to MCSS in 1980 and funding (\$39,000) was granted to run pilot service in spring of 1981. Today the L&A Family Support Program supports approximately 85 children and employs 1.8 FTE. Nine Children are funded through the children with complex special needs funding and the FSW provide the case management and oversight to the directives for these plans. 7 of the 9 children are placed in out-of-home residential settings and 2 children are supported with very enhanced respite plans within their family home.

Kool Kamp provides supports for children with special needs in Lennox & Addington County to attend. Kool Kamp is a day respite program for children ages 4-18 offered one week during March break and 7 weeks throughout the summer. This year will be the 17th camp season.

The organization has active participation on a number of community planning tables and committees:

- Children's Special Needs Steering Committee and COP
- SEAC
- Frontenac, Lennox & Addington Pressures and Priorities Table
- Transition Planning Committee
- Association of Family Support Workers of Ontario
- Frontenac, Lennox & Addington Focus Group
- Frontenac, Lennox & Addington Children's Case Resolution Committee

The organization continues to provide advocacy on behalf of our client families regarding the current needs of children and families in our county, and continues to provide education regarding the issues, rights and needs of individuals with developmental disabilities.

## 6. <u>Educational Services Update: Reporting our Vision for the Future – Enhancing Special Education Services in our Board – Lynne Rousseau – Educational services and Safe Schools Coordinator, Principal Darlene Scarlett and Associate Superintendent McDonnell</u>

L. Rousseau spoke to differentiating supports equitably based upon demographic and socio-economic needs. She explained the differences in the tier levels of support:

- Tier 1 Supports for ALL students: school or class-wide well being promotion programs
- Tier 2 Supports for SOME students: support for at-risk students
- Tier 3 Supports for a FEW students: specialized interventions

Student Support Counsellors support the needs of students with social, emotional, behavioural and/or attendance issues in elementary schools.

Adolescent Care Workers support the needs of students in secondary school with social, emotional, behavioural and attendance issues. There is one worker per secondary site.

School Attendance Counsellors provide intensive support and intervention for high risk students related to attendance issues at both elementary and secondary schools..

- Early identification and intervention
- Problem solving with students, families and schools
- Referrals and collaboration with community partners to address attendance and contributing challenges.

D. Scarlett shared highlights from the Educational Services Learning Series calendar, which include sessions on learning disabilities, Google Read & Write, IEP and Report Card support, and more.

#### 7. <u>Correspondence</u>

 Peterborough, Victoria, Northumberland and Clarington Catholic District School Board

Associate Superintendent McDonnell stated that this letter was referring to the recent changes to Special Education funding. In August 2018, the Special Education Per Pupil Amount () funding increased, but the Special Incidence Portion (SIP) funding has decreased, which can have either a negative or positive effect on individual school boards.

- ii) Policy on Accessible Education for Students with Disabilities (Ontario Human Rights Commission)-Associate Superintendent Alison McDonnell

The Ontario Human Rights Commission (OHRC) has released its new policy on Accessible Education for Students with Disabilities along with recommendations.

LDSB Senior Staff has reviewed the document, and it has been shared with the Accessibility committee and the Educational Services team. The document is an update from the 2004 guidelines.

The OHRC has maintained its policy positions in key areas, including:

- a definition of disability that recognizes the impact of "social handicapping"
- an emphasis on accommodations that promote integration and full participation
- recognition of the central importance of inclusive design in the education context
- recognition that students with disabilities are individuals first, and should be considered, assessed and accommodated on an individual basis
- acknowledgement of the unique ways in which students who identify by the ground
  of disability, along with one or more additional Code grounds (e.g. race, ancestry,
  sex, sexual orientation, etc.) may experience discrimination (i.e. the concept of
  "intersectionality")
- the principle that accommodation is a responsibility shared by all parties to the process
- a reaffirmation of the high standard of undue hardship

The Recommendations to school boards and private educational providers are:

16. Communicate effectively to students, parents, guardians, support persons, etc. through multiple platforms and forums about the right to disability related accommodation, the right of students and parents to participate in the accommodation process, the primacy of the Ontario Human Rights Code, the applicable legislation and requirements, and the dispute resolution options.

- 17. Provide timely and effective accommodation (e.g. by providing early assessment, early intervention or interim accommodation while waiting for a professional assessment), and refrain from obstructing or delaying the accommodation process by rigidly insisting on formalities, unnecessary professional assessments, or diagnosis information.
- 18. Monitor and support education providers to respond appropriately to new or changing demands in the provision of educational services (e.g. an increase in the number of accommodation requests related to mental health disabilities).
- 19. Ensure that all staff and faculty understand the rights and responsibilities set under the Code, the principles of UDL, and are properly trained to respond to disability issues that arise in the primary and secondary educational experience. 20. Identify and end the improper use of exclusions wherein principals ask parents to keep primary and secondary students with disabilities home from school for part or all of the school day (and the role that an improper use of section 265(1)(m) of the Education Act may be playing in this practice).
- 21. Ensure that money currently geared toward the accommodation of students with disabilities is used to remove barriers to inclusive participation and provide supports to all students with disabilities and their teachers.
- 22.Implement Universal Design for Learning (UDL) across all education systems, while continuing to provide accommodation based on individual needs.
- 23.Collect, analyze and make publicly available intersectional, demographic data on students with disabilities and accommodations provided. This data should also identify the nature of the disability (e.g. physical, developmental/intellectual, mental health, etc.), and be disaggregated to determine whether the student identifies with any other Code ground (e.g. sex, race, Indigenous ancestry, etc.). Data collected should include:
  - i. number of students with disabilities in mainstream classrooms versus self-contained classrooms (primary and secondary levels only)
  - ii. number of students with disabilities who are disciplined or excluded from school
  - iii. length of time taken to provide interim and final accommodations from the date of the accommodation request (or when the need is known)
  - iv. length of time taken to resolve accommodation-related disputes
  - v. length of time taken for students with disabilities to complete their programs
  - vi. number of students with a disability who leave their programs before graduating
  - vii. information that would allow for an analysis of disparities in availability of special education supports for students in urban, wealthy school districts versus students from rural, Northern, remote, Indigenous, and/or impoverished school districts

- C. Pepelea shared that LDSB is moving to replace all lighting with LED bulbs. These new bulbs would last 8-15 years longer than the ones currently being used in school sites.

S. Luxford-Oddie shared that there was a recent 'Forest Kindergarten' program at the CRRA with 55 students from Polson Park. The school received a grant to run this week long program.

# Purpose:

To provide information on the new Cashless Schools program.

# Background:

The Limestone District School Board is piloting a Cashless Schools program in five Napanee area schools.

#### **Current Status:**

Selby P.S., Southview P.S., Tamworth E. S., Enterprise P.S., and Napanee District Secondary School are currently piloting a Cashless Schools program which allows for online payment and permissions for school activities. Office staff and all elementary and secondary teachers involved in organizing student activities in these schools received training in November / December.

The 'Go Live' date for these schools was November 26, 2018. This date marked the opportunity for families to sign on with an account in order to be eligible to pay for their child(ren)'s school activities. The pilot is promoting 100% online service for families to pay and give permission. The adoption rate by families within 3 weeks of promotion was 50% or greater in three of the 5 pilot sites. Greater promotion will now take place as schools plan their winter activities.

All information provided through the online process is secure. Families will be able to use Electronic Funds Transfer (EFT) and credit card.

The Cashless Schools pilot will add the remaining Napanee schools (The Prince Charles School, Centreville P.S., Newburgh P.S.) as well as Granite Ridge Education Centre, Land O'Lakes P.S., and Clarendon Central P.S. for a March implementation.

Recently, the team branded the program title for Limestone as 'School Day: Payments and Permissions'.

#### **2018 DIRECTOR'S ANNUAL REPORT**

**JANUARY 16, 2019** 

#### Purpose:

To provide information on the 2018 Director's Annual Report.

# Background:

In compliance with the Education Act, the Limestone District School Board's 2017-2018 Director's Annual Report includes information on:

- the Board's strategic goals and progress the Board has made against these goals in the previous year;
   and
- actions the Board is taking in those strategic priority areas where goals are not being met.

#### **Current Status:**

As was the case last year, boards are being asked to report on our progress in relation to equity and human rights. The release of Ontario's *Education Equity Action Plan* (2017) was a significant milestone in our collective efforts to identify and eliminate systemic barriers to student success. Our strategic plan outlines several goals related to promoting a positive school climate and the prevention of bullying. The 2018 Director's Annual Report contains pertinent information on the Board's progress in our ongoing efforts to promote and meet goals for equity and inclusion, as well as our strategic pillars of Wellness, Innovation and Collaboration.

Since 2011, the Limestone District School Board has communicated its Annual Report in electronic format. The 2018 is now available on the LDSB's strategic plan microsite (<a href="www.seeyourselfinlimestone.ca">www.seeyourselfinlimestone.ca</a>) in compliance with the January 31, 2019 deadline.

Some of the work focused on promoting equity and inclusion included:

- School administrators and educators participated in various professional development sessions
  including collaborative inquiries focused on learning and practices to build a more equitable and
  inclusive school environment.
- The board established an Equity Advisory Committee made up of principals and vice-principals who
  provide feedback and input on the actions that the district is taking in response to the Equity Action
  Plan.
- The board hosted the Student Voice Project, a one-day conference, last spring focused on hearing from Indigenous, LGBTQ+2 and racialized students, making several recommendations to improve how these students see themselves in Limestone and how we can make them feel more welcome and supported.

 Educators focused on implementing Universal Design for Learning, or UDL, an educational framework based on creating flexible learning environments that can accommodate individual learning differences.

#### Other notable accomplishments included:

- The beginning of construction of Kingston Secondary School the city's first high school in 40 years with a ceremonial ground-breaking attended by school and Board staff and community partners.
- The board enhanced its existing partnership with the City of Kingston on two fronts.
  - The board expanded our successful Transit Pass Program nationally recognized by the Federation of Canadian Municipalities for its innovative and sustainable approach to transportation – to include field trip passes for educators at no additional cost.
  - The board also worked closely with the city to open the Rideau Heights Community Centre hub attached to Rideau Heights Public School. The centre's features, including a library, gymnasium, community kitchen, skate park and meeting rooms, are available to students during the school day.
- Trustees approved a balanced budget of \$279.4 million for operations for the 2018-2019 school year
  and included the hiring of four new elementary guidance teachers to support Grade 7 and 8 students'
  academic transition to secondary school and beyond; funding for a multi-disciplinary team of eight
  additional specialists to support special education needs and expanded mental health wellness and
  awareness.
- The Board approved an Action Plan Evaluation Framework for the new strategic plan to allow Trustees to monitor progress under each pillar goal and area of focus. Reports on the status of the first full year, as well as stories of Wellness, Innovation and Collaboration, are outlined on the board's strategic plan microsite, <a href="www.seeyourselfinlimstone.ca">www.seeyourselfinlimstone.ca</a>.
